JANE IS DEDICATED TO NURTURING THE TEAM AROUND HER. BY TRAINING SOME OF OUR EXISTING SUPERVISORS TO BECOME QUALIFIED INSTRUCTORS, THERE IS INCREASED ENGAGEMENT FROM THE TEAM AND WE HOPE THIS WILL RESULT IN GREATER STAFF RETENTION.

NOT ONLY DOES SHE GO THE EXTRA MILE TO ENSURE THAT OUR TRAINING GOALS ARE EXCEEDED, BUT SHE IS DEDICATED TO HER OWN CONTINUED DEVELOPMENT. FOR INSTANCE, HER CONSTANTLY EXPANDING EXPERTISE GIVES US PEACE OF MIND AROUND TRAINING COMPLIANCE. SHE HAS BROUGHT ON BOARD TRUSTED TRAINING PROVIDERS WHO WE KNOW ARE DELIVERING LEGALLY COMPLIANT TRAINING AND WHO HELP US ENSURE WE HAVE THE EVIDENCE WE NEED SHOULD AN ACCIDENT OCCUR. AS WELL AS DELIVERING TRAINING THAT HAS HELPED OUR BOARD TO MEET OBJECTIVES AROUND TRAINING, JANE IS ALSO A FRIENDLY AND HARD-WORKING MEMBER OF OUR TEAM.
